A) Superintendent/Principal's Report

- ELA and Math tests past two weeks for grades 3-8 many more opt outs, as compared to last year
- Since our last meeting the Robotics Team did extremely well in the contest at Hofstra University, and I had the opportunity to see it all first hand; it was very exciting. They came in 3rd going into the finals, and then 8th overall qualifying them as a Rookie Team to go on to St. Louis through generous community support and some field trip monies (as this is a club and a class) they left today to go on to the Competition in St. Louis we look forward to hearing about their success there.
- Elementary students took part in the Budding Authors program at Hampton Library always a wonderful opportunity for our young readers and writers
- We hosted a wellness fair for students in grades 6-12 with the help of the East Hampton Wellness Foundation, and the Retreat – it was terrific, students and staff really enjoyed opportunities to learn about healthy eating, reducing stress, Zumba and the importance of movement – nicely organized by JudiAnn Carmack at the encouragement of the Wellness Committee
- I attended the Josh Levine Memorial Foundation in Sag Harbor on Sunday the 12th- it was a terrific event, also partnered by Slow Foods all proceeds help us to have master farmers in our garden, and support the area school gardens.
- I attended the meeting on School mergers in Southampton last week, it was an overview of the process for schools to merge it appears that there is a follow up committee forming I'll provide information to the board as it is available.
- I have been in contact with the Sag Harbor Superintendent, in discussions about working on shared services to realize savings. I have advised that we are fine for the 1% additional savings we need this year, but would be more than willing to look for future savings with Sag Harbor and perhaps Shelter Island
- Tomorrow I will be attending a reception for educators at Long house in East Hampton –looking forward to learning more about the educational opportunities that are afforded our students there.
- I've completed the budget newsletter that will go out shortly and reviewed with Mr. Hauser all of the other official notifications for the budget, and we are ready for the roll out.
- Next week I will be attending a House of Delegates meeting in Albany on Thursday and Friday (opportunity to meet with the state education department, and secure useful information that assists us as we move forward
- The EH Wellness Center is working with our PreK students and families, and will begin with Kindergarten next week on healthy eating – 6 week program – grant funded – seems to be going well so far.

- A graduate of 1965's spouse has assisted us with gathering the names and addresses, so we've invited the 50 year class to this year's graduation we did this for the 100th year, hoping to make it a part of graduation moving forward.
